### **ORDER**

This Criminal Original Petition has been filed seeking to quash the charge sheet in C.C.No.68 of 2017 on the file of the learned Additional District Munsif Cum Judicial Magistrate, Vedachandur, Dindigul District.

2.The contention of the petitioners is that based on the complaint lodged by the 2<sup>nd</sup> respondent, the 1<sup>st</sup> respondent registered the First Information Report in Crime No.190 of 2014 for the offences punishable under Sections 147, 148, 448, 294(b), 323, 427, 506(ii) of IPC, against the petitioners, subsequently, altered into Sections 294(b), 323, 506(ii) of IPC.

3.The further contention of the petitioners is that they compromised the issue with the 2<sup>nd</sup> respondent amicably. A joint memo of compromise was filed, which has been duly signed by the petitioners and the 2<sup>nd</sup> respondent and also by their respective counsels.

4.The petitioners and the 2<sup>nd</sup> respondent appeared before this Court along with their counsels and also produced their Aadhar cards. They were also identified by the learned Government Advocate (Crl. side) and the Investigation Officer. Both the parties were enquired by me and they accepted the terms of compromise. It is a issue between the village people at the time of village festival. Hence, the Compromise Memo is recorded.

5.Considering the totality of the circumstances, the nature of the allegations levelled against the petitioners and also in view of the joint compromise memo, this Court is of the opinion that no useful purpose will be served by keeping the matter pending and inclined to quash all further proceedings in C.C.No.68 of 2017 pending on the file of the learned Additional District Munsif Cum Judicial Magistrate, Vedachandur, Dindigul District in respect of the petitioners.

6.In the result, the Criminal Original Petition stands allowed and the entire proceedings in C.C.No.68 of 2017, pending on the file of the learned Additional District Munsif Cum Judicial Magistrate, Vedachandur, Dindigul District is
