2.The land belongs to Waqf, therefore, the 1st respondent is empowered to remove the unauthorized occupants. The 1st respondent shall consider the petitioner's representation and by invoking the Act, shall remove the unauthorized occupants. If the petitioner is having any other documents or information regarding the unauthorized occupants, the same shall be given to the 1st respondent. The 1st respondent is directed to take appropriate action as per law.

3.With the above said observation, the writ petition is disposed of.
