2.The petition seeking extension of time has been filed on the ground that the Post of Sessions Judge, Special Court for trial of cases under POCSO Act, Nagercoil, Kanniyakumari District, is kept vacant. Therefore, he could not execute the sureties before him. It has been verified. The learned Government Advocate (Crl. Side) confirmed the fact that the the above said post is kept vacant and the in-charge Officer is Additional District and Sessions Judge, (Fast Track Court), Kanniyakumari at Nagercoil. The Officer in-charge may take up the above said matter and comply the above said order. Let the petitioner surrender before the in-charge Officer and the in-charge Officer shall complete the process as indicated in the above said order.
