ORDER

This petition is filed seeking police protection to the petitioner basing on the representation given by the petitioner dated 13.02.2023.

2.It is submitted by the learned counsel that the petitioner's sister has married the respondent No.6 and though there were disputes between the petitioner's sister and the respondent No.6, subsequently both of them are living together. However, there are issues between both families and a case has been registered against the respondent No.6 on a complaint given by the petitioner for the offences under Sections 294(b), 324, 307 and 506(ii) IPC and after obtaining the bail, the respondent No.6 has been threatening the petitioner with dire consequences, thereby this petition has been filed.
