ORDER

This Writ Petition is filed seeking for a direction to the respondents Police to dispose of the representation of the petitioner dated 20.07.2023. The learned Government Advocate appearing for the official respondents submits that the representation received from the petitioner has been forwarded to the Tahsildar, who seized of the matter and that the representation of the petitioner will be disposed of by issuing notice to the parties concerned.

If at all any such ex-communication is being practising, the Tahsildar is directed to examine the truth and see that the petitioner is permitted to worship and participate in the temple festival and report about the outcome of the enquiry on or before **04.08.2023** as the temple festival is scheduled to be held from **13.08.2023**.

4. Accordingly, this Writ Petition is disposed of. There shall be no order as costs.
