Due to some misunderstanding arose between them, the petitioner filed a petition in H.M.O.P.No.145 of 2022 before the Sub-Court, Devakottai, Sivagangai District, for divorce. The case is pending without any progress for the past one year. Hence, the present civil revision petition is filed.

3. Heard the learned counsel appearing for the petitioner and perused the materials available on record.

4. The learned counsel appearing for the petitioner/husband submitted that the HMOP petition was filed in the year 2022 and even after completion of one year, there is no progress in the matter. Hence, he seeks for speedy disposal of the suit.
