**2.** Learned Government Pleader appearing for the respondents 1 & 2, on instructions, states that the petitioner submitted a representation earlier, however, he did not cooperate for any enquiry and produce any document in support of his allegations against the fifth respondent.

**3.** Learned Government Advocate (Criminal Side) appearing for the respondents 3 & 4, on instructions, states that enquiry with regard to the allegations made by the petitioner against the fifth respondent is already commenced and it is now pending.

**4.** To be noted, the petitioner, who does not cooperate for the enquiry and produce any material in support of his contentions, cannot maintain this writ petition. However, recording the above submissions, this writ petition is closed with an observation that depending upon the outcome of the enquiry, appropriate proceedings may be initiated by the respondents 3 & 4 in accordance with law. No costs.
