After obtaining bail in that case, the petitioner has complied with the condition imposed by this Court without fail.

3.The learned Government Advocate would also admit that the petitioner has complied the condition earlier and due to arrest in some other case, he did not comply with the condition and after his release, now he is complying with the condition imposed by this Court.

4.In view of the above, the condition imposed on the petitioner in CrI.OP(MD) No.11629 of 2023 is modified to the effect that the petitioner has to appear before the respondent Police on the first and third Saturday of every English Calendar month at 10.00a.m., without fail, until further orders.
