This Criminal Original Petition is filed seeking for a direction to the learned Principal District Court (P.C.R), Thanjavur, to consider the bail application of the petitioner on the same day on merits in Crime No.367 of 2021 on the file of the second respondent.

It is submitted by the learned counsel appearing for the petitioner that the petitioner is the accused No.1 in Crime No.367 of 2021 on the file of the second respondent police, which was registered for the offences under Section 294(b) IPC and Sections 3(1)(r) and 3(1)(s) of the SC/ST (Prevention of Atrocities) Act, 1989. .
