This criminal original petition has been filed seeking to quash the FIR in Crime No.10 of 2022 dated 05.07.2022 on the file of the first respondent Police.

2.The contention of the petitioner is that based on the complaint lodged by the 2<sup>nd</sup> respondent, the 1<sup>st</sup> respondent registered the First Information Report in Crime No.10 of 2022 for the offences punishable under Sections 465, 467, 468 and 471 of IPC.

3.When the matter is taken up for hearing, the learned Government Advocate (Crl. side) would submit that after completing the investigation final report has been filed before the Judicial Magistrate No.I, Tirunelveli, through e-filing and the same has not been taken cognizance so far. Hence, the prayer sought for in this petition has become infructuous.
