The petitioner has submitted an application for survey of his land and approached this Court that his application has not been considered by this Court.

In view of the same, the survey could not be completed.

3.Considering the rival submissions made, this writ petition is disposed of with a direction to the Survey Officer to conduct an enquiry under Section 10 of the Tamil Nadu Survey and Boundaries Act, 1923 after issuing notice to the adjacent land owners. In the event, if there is any further objections without any valid reasons, the Survey Officer shall obtain police protection and conduct the survey. Such exercise shall be completed within a period of eight weeks from the date of receipt of a copy of this order.
