This petition has been filed to modify the condition imposed upon the petitioners vide order dated 14.07.2023 in Crl.O.P.(MD).No.12623 of 2023 as to deposit a sum of Rs.50,000/- each to the credit of the crime number.

2. The learned counsel for the petitioners submitted that the petitioners are not in position to comply the above said condition. Hence, seek modification.

3. In view of the submissions made by the learned counsel for the petitioners, the condition imposed upon the petitioner is modified to the effect that the petitioners shall deposit a sum of Rs.50,000/- (Rupees Fifty Thousand only) to the credit of Crime No.295 of 2023. The other conditions remain unchanged. With the above said modification, this petition stands allowed.
