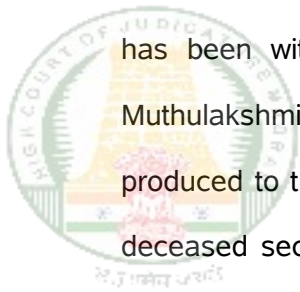

This case came up for settlement before the Lok Adalat. Both the parties present. The counsel for the appellant/s Mr.V.J.Kumaravel and the counsel for the respondent/s Mr.P.Chinnasamy are present. After mutual discussion, negotiation, mediation and conciliation between both parties and with the assistance of the Bench, both sides consented for settlement.

AWARD

Both sides present. As per the settlement arrived in the Lok Adalat, both parties have agreed to settle the amount of **Rs.29,50,000/- (Rupees Twenty Nine Lakhs and Fifty Thousand only)** with interest at the rate of **7.5% from the date of petition till the date of deposit.** It is represented by the learned

has been withdrawn by the claimants. It is represented that the wife of the first claimant, namely, Muthulakshmi/second claimant died on 24.09.2021 and Death Certificate dated 20.12.2021 has been produced to that effect. Hence, the first claimant is entitled to receive his share and also the share of the deceased second claimant, who is his wife. The appellant/Insurance Company is directed to deposit the balance award amount along with interest within a period of **4 weeks** from the date of receipt of a copy of this order. On such deposit, the claimants are permitted to withdraw their share amount without filing formal petition before the Tribunal.
