2. The learned counsel for the petitioners submitted that it is a case in counter case and the defacto complainant suffered only simple injuries. He further submitted that the petitioners are agriculture coolies.

3. Heard the learned Government Advocate (Crl.Side) appearing for the respondent police.

4. Considering the nature of injury suffered by the defacto complainant, the condition No.5(a) imposed on the petitioners by this Court in Crl.O.P.(MD)No.11109 of 2023 dated 22.06.2023 is modified and the petitioners shall pay a sum of Rs.15,000/- (Rupees Fifteen Thousand only) jointly, to the defacto complainant directly and on production of proof/ acknowledgment the learned Magistrate shall accept the sureties furnished by the petitioners.
