This Criminal Original petition has been filed to direct the learned Judicial Magistrate Court, Oddanchatram, to recall the Non-bailable warrant issued against the petitioner on 02.06.2020 in S.T.C.No.26 of 2020.

2. The petitioner facing the charges under Section 138 of Negotiable Instruments Act, before the Judicial Magistrate Court, Oddanchatram in S.T.C.No.26 of 2020. Because of the non appearance of the petitioner, before the trial Court, non- bailable warrant issued against the petitioner.

3. The learned counsel for the petitioner submitted that the summon was issued by the trial Court against the petitioner for his appearance.
