ORDER

[Order of the Court was made by S.M.SUBRAMANIAM, J.]

The relief sought for in this writ petition is to direct the respondents 1 to 6 to remove the encroachments made by the seventh respondent and his men on the panchayat road in R.S.Nos.45/1, 45/2A & 45/9 in the sixth respondent village panchayat and to direct the respondents 1 to 6 to lay a thar road and maintain the same ever free from encroachment and take action against the seventh respondent and his men, based on the representation of the petitioner dated 16.05.2023.

2. Learned Additional Government Pleader appearing for the respondents 1 to 5, on instructions, submitted that the third respondent / Block Development Officer has already submitted a report and based on the

same actions are being taken to conduct a survey and to remove encroachments, if any.

Since the process of conducting survey and removal of encroachments, if any identified, has already been commenced, the official respondents are directed to proceed with the same by following the procedures as contemplated and remove the encroachments, if any identified, as expeditiously as possible.

4. With the above direction, the writ petition is disposed of. No costs. Consequently, connected miscellaneous petition is closed.
