Learned counsel for the petitioner submits that the petitioner is proposed to conduct the Bullock Cart race on 13.08.2023, for which, the learned Government Advocate (Criminal Side) after consulting with the concerned Inspector of Police reports that the respondent Police will have no objection to permit the petitioner to conduct the Bullock cart race on 13.08.2023 and the permission will be accorded.
