This case came up for settlement before the Lok Adalat. Both the parties present. The counsel for the appellant/s MR.E.Chandrasekaran and the counsel for the respondent/s MR.V.Muthukamatchi are present. After mutual discussion, negotiation, mediation and conciliation between both parties and with the assistance of the Bench, both sides consented for settlement.

AWARD

Both sides present. As per the settlement arrived in the Lok Adalat, both parties have agreed to settle the amount of **Rs.13,30,000/- (Rupees Thirteen Lakhs and Thirty Thousand only)** with interest at the rate of **7.5% from the date of petition till the date of deposit**. The appellant/Insurance Company is directed to deposit the entire award amount, less the amount already deposited, if any, within a period of **4 weeks** from the date of receipt of a copy of this order. On such deposit, the claimant/respondent No.1 is permitted to withdraw the award amount without filing formal petition before the Tribunal.
