The grievance of the petitioner is that he has participated and also submitted his tender document for certain works as per the tender notification dated 03.07.2023. Though the petitioner has approached the respondents for several times, the auction has not been conducted.

3.Mr.M.Sarangan, learned Additional Government Pleader, who takes notice for the respondents on written instructions submits that the tender process was withheld on 21.07.2023 on technical ground and re-scheduled and will be held on 10.08.2023.
