The present writ petition has been filed seeking direction to the respondent to pay interest at the rate of 6% per annum to the petitioner for the belated payment of Gratuity, Provident fund, leave salary and pension commutation from the date of retirement to the date of actual payment within a time frame to be fixed by this Court.

2. By consent of both parties, this Writ Petition is taken up for final disposal at the stage of admission itself.

3. The petitioner was employed as Cleaner by the respondent Corporation on 26.11.1986. He retired from service on 30.04.2022.

4. It is admitted that his terminal benefits were not settled immediately but only belatedly. The only question that arises for consideration is as regards the rate of interest payable on the belated settlement.

5. The issue raised in this writ petition was already decided by this

In view of the above, this Writ Petition stands disposed of by directing the respondent Corporation to pay interest at the rate of 6% per annum for belated settlement of petitioner's terminal benefits including Gratuity, Provident fund, leave salary and pension commutation. This shall be done within a period of twelve (12) weeks from the date of receipt of a copy of this order. There shall be no order as to costs.
