2.The case of the prosecution is that due to previous enmity, on 03.06.2023, at about 6.15 a.m., when the defacto complainant was sleeping in his house, the petitioner along with other accused attacked him with sword and caused criminal intimidation. Hence, the complaint.

3.The learned counsel for the petitioner submitted that the petitioner is an innocent person and she has not committed any offence as alleged by the prosecution.

4.The learned Additional Public Prosecutor submitted that there is (*) six previous cases against the petitioner. The investigation is still pending.

5.Considering the period of incarceration(**) (deleted), this Court is inclined to grant bail to the petitioner with stringent conditions.

6.Accordingly, this Criminal Original Petition is allowed and the petitioner is ordered to be released on bail, on executing a personal bond for a sum of

Rs.10,000/- (Rupees Ten Thousand only) with two sureties each for a like sum to the satisfaction of the learned Judicial Magistrate No.I, Ramanathapuram and on further condition that the petitioner shall report before the respondent police daily at 10.30 a.m. until further orders. The petitioner shall also file an undertaking affidavit before him, to the effect that he will not commit any such offence in future.
