ORDER

This Criminal Original Petition is filed under Section 482 of the Code of Criminal Procedure seeking for expeditious completion of the investigation in Crime No.6 of 2022 dated 24.02.2022.

2.It is submitted by the learned counsel that the petitioner/the defacto complainant has filed a complaint stating that the accused have committed cheating of Rs.78,00,000/- and that the police have registered a case in Crime No. 6 of 2022, there is no substantial progress, thereby sought for suitable directions to expedite the investigation.
