2. Heard Mr.M.Suresh, learned counsel appearing for the petitioner, Mrs.D.Farjana Ghoushia, learned Special Government Pleader appearing for the respondents 1 to 6 and Mr.G.Mathavan, learned counsel appearing for the seventh respondent.

Considering the prayer sought for in the writ petition and also considering the fact that the representation has been made as early as in the year 2014, the writ petitioner is directed to make a fresh representation to the respondents 6 and 7 within a period of two weeks from the date of receipt of a copy of this order. On receipt of such representation, the respondents 6 and 7 shall consider the representation of the petitioner and pass appropriate orders on merits and in accordance with law within a period of twelve (12) weeks thereafter.
