2. The prosecution case is that the accused persons have illegally transported 4 unit of quarry stones through the lorry bearing Registration No.TN 46 M 7796. Hence, the complaint.

3.The learned counsel for the petitioner submitted that the petitioner has not committed any offence as alleged by the prosecution. He is the driver of the above said vehicle. He would further submit that the petitioner is in judicial custody from 29.07.2023.

4.The learned Additional Public Prosecutor appearing for the respondent police submitted that the petitioner is working as lorry Driver and is having no previous case at his credit.

5.Considering the facts and circumstances of this case and considering the duration of custody, this Court is inclined to grant bail to the petitioner with certain conditions;

Accordingly, this Criminal Original Petition is allowed and the petitioner is ordered to be released on bail, on executing a personal bond for a sum of Rs.10,000/- (Rupees Ten Thousand only) with two sureties each for a like sum to the satisfaction of the learned District Munsif cum Judicial Magistrate, Aravakurichi, and on further condition that the petitioner shall report before the respondent Police daily at 10.30 a.m. until further orders.
