ORDER

This writ petition is filed by the petitioner seeking a mandamus directing the respondents to receive a sum of Rs.14,21,517/- towards the award amount, as per the award dated 31.11.2011 and to direct the respondents to adjust the margin amount to the tune of Rs.1,00,000/- paid by the petitioner with interest from 08.12.1995.

When the matter came up for hearing on 07.03.2023, learned Counsel for the petitioner reported that the petitioner died and for impleading the legal heirs, he sought for a short accommodation. Accordingly, time was granted and the writ petition was adjourned.
