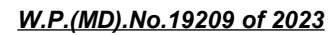
ORDER

The present writ petition has been filed seeking direction to the respondents to pay 6% interest for the belated payment of Terminal Benefits such as P.F., Gratuity and Leave Salary, payable to the petitioner from the date of petitioner's husband retirement (i.e.) on 31.01.2019 to till the date of actual payment made to him (i.e.) 21.09.2019.

2. By consent of both parties, this Writ Petition is taken up for final disposal at the stage of admission itself.

3. The petitioner's husband was employed as Conductor (Daily wage) by the respondents Corporation on 19.09.1986. He retired from service on 31.01.2019.

4. It is admitted that the petitioner's husband's terminal benefits were not settled immediately but only belatedly. The only question that arises for consideration is as regards the rate of interest payable on the belated settlement.



6. In view of the above, this Writ Petition stands allowed by directing the respondent Corporation to pay interest at the rate of 6% per annum for belated settlement of petitioner's husband's terminal benefits. This shall be done within a period of twelve (12) weeks from the date of receipt of a copy of this order. There shall be no order as to costs.
