ORDER

The present writ petition has been filed seeking direction to the respondents to settle interest at the rate of 6% per annum for the belated payment of petitioner's terminal benefits including Provident Fund, Gratuity, Terminal Leave Salary and Commuted Value of Pension from the date of his retirement i.e from 31.05.2022 to 30.05.2023 the date on which the said benefits were settled to him.

2. Heard the learned counsel on either side.

3. The petitioner was employed as Conductor by the respondent corporation on 24.10.1997. He retired from service on 31.05.2022.

4. It is admitted that his terminal benefits were not settled immediately but only belatedly. The only question that arises for consideration is as regards the rate of interest payable on the belated settlement.
