Prayer:-

Writ Appeal filed under Clause 15 of the Letters Patent Act, to allow this writ appeal by setting aside the order dated 17.11.2014 made in W.P.(MD) no.11111 of 2009 on the file of this Court.

Prayer in W.P.(MD) no.11111 of 2009 :-

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court To issue a Writ of Certiorarified Mandmamus, calling for the records on the file of the 2nd respondent herein in Roc. No. A1/516/2008 (TDP.No. 18 of 2009) dated 13/10/2009 and quash the same and to issue consequential directions



to the 1st respondent herein to treat the period of the petitioners suspension from 14/10/2003 to 10/06/2004 as duty period with all consequential benefits.
