2. The case of the prosecution is that the petitioner has received money from the defacto complainant for arranging Government Job. Thereafter, he has neither arranged the job nor returned the money. Hence, the complaint.

3. The learned Additional Public Prosecutor appearing for the respondent police would submit that on the basis of the complaint given by the defacto complainant, enquiry is pending and on the point of jurisdiction, enquiry was transferred to District Crime Branch, Thanjavur.

4. Let the above said enquiry be completed within a period of fifteen days from the date of receipt of a copy of this order. During the course of enquiry, if any trouble arises, the petitioner is at liberty to workout his remedy through appropriate proceedings.

5. With the above said directions, this criminal original petition stands disposed of.
