ORDER

Heard the learned counsel on either side.

2.The fifth respondent herein filed a revision before the District Revenue Officer seeking changes in the revenue record in respect of the petition mentioned survey numbers. His case was accepted and the impugned order dated 10.06.2015 came to be passed. This operated to the prejudice of the writ petitioner herein. The writ petitioner was not heard before passing the impugned order. On this sole ground, the

The District Revenue Officer, Sivagangai will issue fresh notice of enquiry to the petitioner, fifth respondent and other stakeholders, if any. 3.This writ petition is allowed on these terms. No costs.
Consequently, connected miscellaneous petition is closed.
