3.The learned Government Advocate (Crl.side) on the other hand submits that since the petitioner is involved in a murder case, he is being monitored regularly by the police and the police would certainly follow the guidelines issued by this Court in W.P.(MD) Nos.21040 of 2018 and batch dated 03.07.2020 and dispose of the request of the petitioner.

4.In view of the above, this Petition is disposed of directing the respondent police to dispose of the representation of the petitioner dated 11.07.2023 scrupulously by following the directions issued by this Court in W.P.(MD) Nos. 21040 of 2018 and batch dated 03.07.2020. No costs.
