ORDER

This Criminal Original Petition is filed under Section 482 of the Code of Criminal Procedure seeking for a direction to the respondents 2 to 4 not to interfere with the civil dispute on the basis of the petitioner's representation dated 07.08.2023.

2. According to the learned counsel for the petitioner, there was a dispute between the petitioner and the fifth respondent, which are purely civil in nature. However, based on the the complaint given by the fifth respondent to the respondents 2 to 4, the respondents harassing the petitioner, therefore, sought for suitable direction.

3. The learned Government Advocate (Crl.side) on the other hand submitted that the complaint given by the fifth respondent is registered in C.S.R.No.1228 of 2023 and after due enquiry, the said petition was closed stating that the dispute between the petitioner and the fifth respondent is civil in nature and thereby, the petitioner is not at all being called with regard to the said dispute.
