ORDER

This petition is filed under Section 482 of Cr.P.C. seeking for a direction to respondent Police to provide suitable protection from the unofficial respondents.

2. According to learned counsel for the petitioners, there are civil disputes between the petitioners and unofficial respondents and O.S.No.414 of 2023 and H.M.O.P cases are pending between them, however, on 30.07.2023, at about 08.00 A.M. the unofficial respondents trespassed into the property belonging to the petitioners and committed an offence, therefore, sought for suitable police protection.

3. Learned Government Advocate (Criminal Side), on the other hand, submits that, the request for providing police protection was filed in KK Nagar Police Station, however, the petitioner is expected to file an application before the Navalpattu Police Station.
