Prayer in CRL MP(MD). 9572/ 2021 :

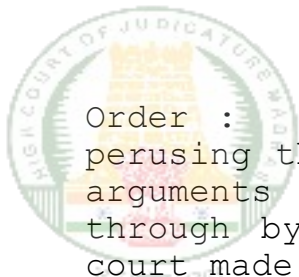
