petitioner vide order dated 22.06.2023 in CrI.O.P.(MD).No.11146 of 2023 as to deposit a sum of Rs.4,00,000/- to the credit of the crime number.

2.Only on the basis of the undertaking given by the petitioner to deposit the above said amount, which is the subject matter of the crime number, the above said order was passed directing the petitioner to deposit the above said amount.

3.The learned counsel for the petitioner would submit that due to the family situation, he is not in position to arrange the above said amount. The petitioner is in custody for more than 93 days.

4.The total amount involved is more than Rs.16 lakhs, which is a job racketing issue. Considering the seriousness of the offence and also considering the amount involved, I find no reason to modify the above said condition.

5.Accordingly, this criminal miscellaneous petition is dismissed.
