quash the same and consequently direct the respondents to grant permission to have an Aavin Booth at the 3rd Respondent premises by considering the Petitioner's representation dated 19.05.2014 within a time frame that may be stipulated by this Court.

ORDER

Heard the learned counsel on either side.

2.The petitioner wants to run a canteen in the premises of the third respondent government hospital. The petitioner's request was negatived. Challenging the same, the present writ petition has been filed.

3.The learned Additional Government Pleader points out that the Government has issued G.O.(Ms)No.194, dated 21.06.2022 laying down the guidelines for opening milk parlor / tea shop / canteen within the

premises of government hospital. The petitioner has to necessarily avail the remedy under the aforesaid government order. The writ petition has virtually become infructuous.

4. Granting liberty to the petitioner to workout his remedy in the manner known to law, this writ petition is dismissed. No costs. Consequently, connected miscellaneous petitions are closed.
