ORDER

The petitioner has approached this Court that the respondents have not paid the compensation amount for the land which has been acquired from his father in the year 1978.

2.Mr.P.T.Thiraviam, learned Government Advocate, who takes notice for the respondents, on instructions, submits that the land was acquired from the petitioner's father one Perumal Pillai in the year 1978 and after the enquiry, compensation of Rs.29,842.15/- was deposited in Indian Bank Esplanade, Madras in the name of the Registrar, High Court of Madras in SB Account No.14443, dated 08.09.1984. The learned Government Advocate has also produced the relevant proceedings of the Director of Adi Dravidar and Tribal Welfare, Chepauk, Madras, dated 04.09.1984, the proceedings of the Special Tahsildar (Land Acquisition), Adi Dravidar Welfare,
