ORDER

2.The petitioner challenges the order passed by the Government under Section 70 of the Chits Fund Act, 1982. The petitioner is a subscriber in the chit conducted by the third respondent. The petitioner had defaulted. The third respondent availed arbitral remedy. The award dated 27.01.2012 was passed by the second respondent. Challenging the same, the petitioner filed appeal. The appeal was also dismissed on
