ORDER

This Criminal Original Petition is filed under Section 482 of Cr.P.C. seeking for quashment of FIR in Crime No.1302 of 2020 on the file of the first respondent Police for the offences under Sections 147, 148, 294 (b), 323, 342, 353, 332, 307, 269 and 188 of I.P.C. r/w Section 3 of the Tamil Nadu Public Property (Prevention of Damage and Loss) Act, 1992.

2. Heard the learned counsel for the petitioner.

3. When the matter was taken up for hearing, learned Additional Public Prosecutor submitted that the investigation in this case has already been completed and charge sheet is made ready and about to be filed before the concerned learned Judicial Magistrate.
