The Civil Miscellaneous Appeal is preferred by the Insurance Company against the award of the Tribunal awarding a sum of Rs.23,61,800/-. Now the parties have agreed for a sum of Rs.19,11,800/- along with interest at the rate of 7.5% per annum from the date of filing of the petition till the date of deposit, ie., on 25.11.2022.

2.The appellant Insurance Company has already deposited the entire award amount. The appellant insurance company is entitled to withdraw the balance amount, if any, along with accrued interest.

3.The respondents 1 & 2 shall be entitled to withdraw their respective share along with accrued interest. The share of the minor 3rd respondent shall be deposited in any of the nationalized Bank. The first respondent shall be entitled to withdraw the interest of the minor claimant once in six months till she attains majority.
