Considering the submissions made by the learned Government Advocate (Criminal Side), since the complaint is stated to have been filed against the petitioner and respondent No.3, since the respondent Police have already initiated the enquiry, the petitioner is directed to appear before the Police in C.S.R.No.857 of 2023 and the respondent Police are directed to

complete the enquiry as quickly as possible not later than within a period of two weeks from the date of receipt of a copy of this order.
