ORDER

The petitioner has approached this Court that the 3rd respondent, namely, the Divisional Engineer, Highways Department, NABARD and Rural and Village Rods Wing, Dindigul, has laid a thar road in his patta land, without acquiring his land under the Land Acquisition Act and therefore, he sought for a direction to remove the road laid down in his patta land.

2. Today, when the matter is taken up for hearing, the learned counsel appearing for the petitioner submits that the road, which has

been laid in the petitioner's patta land, has been removed.
