Be that as it may, the jurisdictional Tahsildar has given written instructions to the learned Additional Government Pleader that till date, in the village accounts, the names of the individuals continues to be reflected. It appears that the petitioner's land has not been taken possession till date. If the petitioner or another individual has any subsisting legal grievance, it is always open to them to move this Court again.

3. With this liberty, this writ petition is disposed of. No costs. Consequently, connected miscellaneous petitions are closed.
