ORDER

(Order of the Court was made by M.S.RAMESH,J.)

When the petitioner's son, namely, A.Robinson, aged about 19 years, had gone missing, she had given a complaint on 14.07.2023 before the second respondent police. Since the petitioner's son could not be traced within a reasonable time, she has filed the present Habeas Corpus Petition.

2. Today, when the matter was called, the learned Additional Public Prosecutor submitted that the petitioner's complaint has been registered in Crime No.229/2023 on 14.07.2023 as man missing and that the second respondent police is conducting the investigation to locate the petitioner's son.

3. Since the second respondent had registered the petitioner's complaint and are in the process of investigating, we deem it fit that the second respondent could be directed to expedite the investigation and file a final report.
