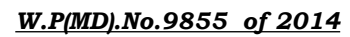

The present Writ Petition has been filed seeking for a Mandamus directing the third respondent to provide opportunity and implement the RBI Circular Vide No. RBI/2007-2008/330 RPCD.No.PLFS.BC.72/05.04.02/2007- 2008, dated May 23, 2008 called as Agricultural Debt Waiver and Debt Relief Scheme, 2008 with regard to the petitioner's loan.

3. Pursuant to the same, the petitioner had given a representation to the respondents dated 29.04.2014. The respondents through their advocate had replied to the representation stating that the request of the petitioner could not be accepted by the Bank and that the Bank would initiate legal action, if the petitioner does not close the loan account within fifteen days. Thereafter, the petitioner had made a further representation on 15.05.2014 making the similar request and had filed this writ petition to direct the respondents to consider the implementation of the Scheme.
