2. The case of the prosecution is that on 21.07.2023, on secret information, the respondent Police made surprise visit in the place of Thalapparvai, wherein the petitioner attempted to illegally transport. Hence, the case.

3. The learned counsel for the petitioner submitted that the petitioner is an innocent. Only for statistical purpose, this case has been registered against the petitioner.

4. The learned Government Advocate (Crl.Side) would submit that, the petitioner is involved in one previous case in Crime No.109 of 2019 for the offences under Sections 379 and 511 IPC.

5. Considering the facts and circumstances of this case and also considering that the petitioner is involved in previous case, which is in similar nature, this Court is not inclined to grant anticipatory bail to the petitioner. Hence, this anticipatory bail petition deserves dismissal and accordingly dismissed.
