ORDER

This petition is filed by the petitioner / *defacto* complainant seeking for earlier completion of investigation in Crime No.70 of 2022, dated 10.05.2022.

2. It is submitted by learned counsel for the petitioner / *defacto* complainant that on a complaint given by him, a case in Crime No.70 of 2022 was registered on the file of the respondent police for the offence punishable under Sections 447, 427, 294 (b), 341, 419, 420 and 506 (2) IPC and delay is occurred in completion of investigation, therefore, sought for suitable directions.

3. Learned Government Advocate (Criminal Side) submits that the respondent Police have completed the investigation in Crime No.70 of 2022 and filed a final report before the concerned learned Magistrate and closed the FIR as “Mistake of Fact” on 07.08.2023.
