2. The case of the prosecution as per the defacto complainant's version is that his son by name Madhanavel was studying 10th standard and later dropped out. There was a behavioural change. On noticing the same, he made enquiry and he informed that he was supplied Ganja by Sivakumar, Surya, Maharajan, Thiruppathi and one Samuthiram. On the basis of the information furnished by him he lodged a complaint and a case was registered.

3. The learned counsel for the petitioner submitted that the petitioner is an innocent person and he has not committed any offence as alleged by the prosecution.

4. The learned Additional Public Prosecutor submitted that totally 50 grams of Ganja has been recovered. No previous case is pending against him. A6 & A1, the co-accused in this case have been released on bail by this Court.

5. Considering the period of incarceration and the fact that co-accused/ A6 & A1 in this case have been released on bail by this Court, this Court is inclined to grant bail to the petitioner with stringent conditions.

6. Accordingly, this Criminal Original Petition is allowed and the petitioner is ordered to be released on bail, on executing a personal bond for a sum of Rs.10,000/- (Rupees Ten Thousand only) with two sureties each for a like sum to the satisfaction of the learned Judicial Magistrate No.I, Sivakasi and on further condition that the

petitioner shall report before the respondent police daily at 10.30 a.m. until further orders.
