Now the petitioner is complying the condition without fail from 18.07.2023. The petitioner is an aged person and he is having diabetic and taking treatment and he is unable to comply the condition and hence, he filed this petition for relaxation.

3.The learned Government Advocate appearing for the respondent also admitted that the petitioner is complying the condition without fail.

4.Taking into consideration that the petitioner is complying the condition regularly and the health condition of the petitioner, the condition no.5(b) imposed on the petitioner directing him to appear before the respondent police daily at 10.00 am., until further orders is alone modified to the effect that the petitioner shall report before the respondent police at 10.00 a.m., in every first working day of English Calendar month until further orders. All other conditions shall remain unaltered.

5.Accordingly, the Criminal Miscellaneous Petition is allowed.
