Prayer:- Petition filed under Article 226 of the Constitution of India praying for issuance of a writ of Habeas Corpus calling for the entire records connected with the detention order of the respondent No.2 in No. 59/BCDFGISSSV/2023 dated 13.07.2023 and quash the same and direct the respondents to produce the detenu by name Velprathap, son of Velmurugan aged about 22 years, who is detained in District Prison, Dindigul before this Court and set him at liberty forthwith.

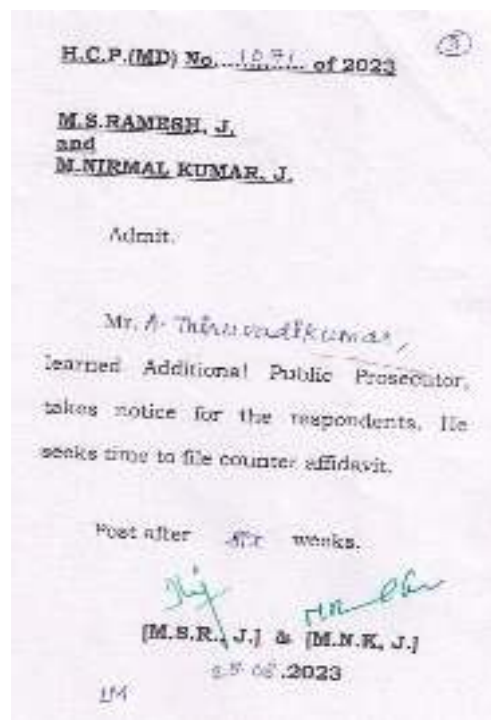

ORDER

When the captioned 'Habeas Corpus Petition' [hereinafter 'HCP' for the sake of brevity] was listed in the Admission Board on 25.08.2023, a Hon'ble Coordinate Division Bench made the following order in the Admission Board:

2. It has now become necessary to set out a thumbnail sketch of factual matrix and we do so in the paragraphs infra.

3. Today, the captioned matter is in the Final Hearing Board.

4. Mr.S.Maya Perumal, learned counsel on record for petitioner and Mr.A.Thiruvadi Kumar, learned State Additional Public Prosecutor for all respondents are before us.

5. Captioned HCP has been filed by the father of the detenu assailing a 'preventive detention order dated 13.07.2023 bearing No. 59/BCDFGISSSV/2023' [hereinafter 'impugned preventive detention order' for the sake of brevity and convenience]. To be noted, sponsoring authority has not been arrayed as a respondent but we find that Station House Officer of 'B3 Teppakulam Police Station' is the sponsoring authority [hereinafter 'Sponsoring Authority' for the sake of convenience and clarity] and second respondent is the detaining authority as impugned preventive detention order has been made by second respondent.

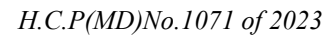

6. Impugned preventive detention order has been made under 'The Tamil Nadu Prevention of Dangerous Activities of Bootleggers, Cyber law offenders, Drug-offenders, Forest-offenders, Goondas, Immoral traffic offenders, Sand-offenders, Sexual-offenders, Slum-grabbers and Video Pirates Act, 1982 (Tamil Nadu Act No.14 of 1982)' [hereinafter 'Act 14 of 1982' for the sake of convenience and clarity] on the premise that the detenu is a 'Goonda' within the meaning of Section 2(f) of Act 14 of 1982.

7. There is one adverse case and one ground case. The ground case which constitutes substantial part of substratum of the impugned preventive detention order is Crime No.211 of 2023 on the file of B3 Teppakulam Police Station for the alleged offences under Sections 147, 148, 341, 294(b), 324, 307, 302 and 506(ii) of 'The Indian Penal Code (45 of 1860)' [hereinafter 'IPC' for the sake of convenience and clarity]. Considering the nature of the challenge to the impugned preventive detention order, it is not necessary to delve into the factual matrix of the case.

8. In the final hearing today, learned counsel predicated his campaign against the impugned preventive detention order on the point that the detenu was arrested on 20.05.2023 but the impugned preventive detention order has been made only on 13.07.2023 resulting in live and proximate link between

11. To be noted, **Banik** case has been respectfully followed by this Court in **Gomathi Vs. The Principal Secretary to Government and others** reported vide Neutral Citation of Madras High Court being **2023/MHC/334**, **Sadik Basha Yusuf Vs. The State of Tamil Nadu and others** reported vide Neutral Citation of Madras High Court being **2023/MHC/733**, **Sangeetha Vs. The Secretary to the Government and others** reported vide Neutral Citation of Madras High Court being **2023:MHC:1110**, **N.Anitha Vs. The Secretary to Government and others** reported vide Neutral Citation of Madras High Court being **2023:MHC:1159** and a series of similar orders in HCP cases.

12. To be noted, the adverse case is in Crime No. 604 of 2021 on the file of B4 Keeraithurai Police Station for alleged offences under Sections 294(b), 324 and 506(ii) of IPC and Section 25(1B)(b) of Arms Act, 1959 [alleged occurrence on 23.08.2021], ground case is Crime No.211 of 2023 on the file of B3 Teppakulam Police Station, for alleged offences under Sections 147, 148, 341, 294(b), 324, 307, 302 and 506(ii) of of IPC [alleged occurrence on 19.05.2023] and therefore time consumed remains unexplained.

WEB COPY 13. Before concluding, we also remind ourselves that preventive detention is not a punishment and HCP is a high prerogative writ.

14. Ergo, the sequitur is, captioned HCP is allowed. Impugned preventive detention order dated 13.07.2023 bearing No. 59/BCDFGISSSV/2023 made by the second respondent is set aside and the detenu Thiru.Velprathap, aged 22 years, son of Velmurugan, is directed to be set at liberty forthwith, if not required in connection with any other case / cases. There shall be no order as to costs.
